We should look at planning for the next MLK activities and the MLK essay contest. We also need to look at getting more schools involved. We should also look at the HRC's support of February Black History Month following the MLK Breakfast.

  - o Other areas include Chamber of Commerce and Charter School.
  - o Would like for members to continue to brainstorm in this area.

• <u>Candidates Forum.</u> County Manager, Michael Felts noted that this is a General Election year and it would probably be unlikely for the HRC to sponsor two forums (Primary and General). Following much discussion on the Candidate's Forum, a motion for the HRC to support a Candidates Forum only for the General Election in November was presented by David Smith, second by Jason Jenkins and so moved by Chairman Gooch.

It was noted that we need to start building the layout for the Candidate Forum at the next meeting and by September have the final layout. We will look at having the forum at the Expo Center in October.

It was recommended that we have Panel session from candidates versus individual sessions. We can have a reception period for candidates to speak with individuals at the forum.

In consideration of the time, it was also recommended that we have written questions, received in advance from the audience/public, and not open questions from the audience during the session.

HRC should consider putting a notice in the paper reminding community to get out and vote.

• Other. Ms. Cordrey provided all members with "Daily Bread" booklets in recognition of Black History Month.
