



GRANVILLE ATHLETIC PARK TENNIS & SAND VOLLEYBALL RULES & REGULATIONS

Submission of payment for this reservation will serve as acknowledgement and agreement that you have read and will abide by the facility rental rules and regulations as stated below. The act of submission will constitute the electronic rental agreement. A copy of these rules will be emailed to the address associated with the rental upon completion of the reservation process and payment of all fees. Failure to receive the email communication shall not in any way void agreement to abide by these rules and regulations.

1. The name on the CivicRec account from which the rental reservation is submitted shall be considered the "Responsible Party" and shall be responsible for maintaining order and decorum when using the facility, and to fully inform group members, affiliates, and guests of these rules and regulations.
2. Operating hours for the Granville Athletic Park are daily from dawn to dusk.
3. Tennis courts 1-3 are lit and players may utilize those courts until 10:00 pm; Courts 4-6 are not lit and may be utilized until dusk only. Two sand volleyball courts are available and may be utilized until dusk only.
4. Use of the tennis courts and sand volleyball pits is at user's own risk.
5. Tennis court gates must remain closed at all times.
6. Fees must be paid at time of reservation to secure the reservation.
7. Rates for organized groups requesting long-term reservations for multiple courts (i.e., tennis associations) may be negotiated through County administration on a case-by-case basis.
8. Reservation requests must be made at least 24 hours in advance and can only be made up to one week in advance.
9. Individual users must notify Granville County Parks & Grounds within 24 hours of any weather-related cancellation to have a credit issued for future play. Credits do not happen automatically.
10. Tournament or group users must provide Granville County Parks & Grounds with a 72-hour notice of any weather-related cancellation to have a credit used for future play. Credits do not happen automatically.
11. Open courts that have not been reserved are available on a first-come/first-served basis. When others are waiting, the time limit for non-reserved court play is one hour (singles) or 1 ½ hour (doubles), and one hour for sand volleyball pits.
12. Pets, bicycles, roller blades, skateboards, or other similar activities, street shoes (tennis shoes only), food or glass containers, sitting, pushing, or pulling on nets, firearms, fireworks, fires, pyrotechnics, and alcoholic beverages are prohibited.
13. Private instruction and/or classes unless written permission is received from Granville County Parks & Grounds
14. Granville County assumes no responsibility for stolen items or for damage to vehicles in the parking lot.
15. Music that is amplified and disturbs others is not permitted.
16. The Responsible Party shall be liable for any loss, damage, or injury sustained by any person(s) during the course of the reservation period. All repair or replacement costs incurred as a result of damage, including but not limited to County staff labor costs, will be itemized and billed directly to the Responsible Party.
All charges must be paid within 30 days to avoid legal action.
17. The Responsible Party and his/her agents must comply with and abide by all laws and ordinances which may apply to the use of this facility including federal, state, county, and municipal.
